### Usage Guidelines

There are certain guidelines we must enforce to ensure the appropriate licensing regulations are being followed.

JPG and PNG files are provided for web use only (they are not high-resolution enough for print). For print or design purposes, please use the TIF and EPS files.

PLAYBILLder - we've provided you with a JPG for use with PLAYBILLder.com (online tool that lets you build your very own Broadway-quality Playbill), pre-sized for uploading into the cover page template. Since PLAYBILLder allows you to import your producing organization's information in the trademark yellow headline bar, you do not need to add it to this graphic.

You may not recolor, adjust, or resize elements of the logo or artwork, or use the logo with conflicting or non-complementary key art (backgrounds or other assets).

1 color Black/White files are to be used only when absolutely necessary. Do not use these files for digital marketing or when printing/designing in color.

This logo is licensed to you with accompanying background asset (CHARLIE\_XA\_BACKGROUND.TIF). While you may use the provided title treatments on their own, you may not use any other key art not provided in this logo pack. Conversely, you may not use the provided background with any other title treatments not provided to you in this logo pack.

When using the provided background you may NOT use the 1 color black title treatment. You may use the 4C title treatments centered over the pink burst element on the background file. You may crop the background file for your unique sizing needs.

### Incorrect Usage Examples





Do not recolor artwork.

Do not resize or adjust individual elements.



Do not use conflicting or non-complementary backgrounds. Do not use Title treatment with key art not provided in this logo pack.

#### **Correct Usage Examples**



With 4C title treatments you may use XA\_background.



Use TIFF files for print and JPG/PNG files for Digital.



Do not use the BW title treatment with the XA\_Background.



With 4C title treatments you may use suggested background colors.



Only use BW files when absolutely necessary. Must be used on a white background.
